- 10. ADOPTED THE DRAFT NOMINEE DATA FORM for use by the Huntsville Presbytery for persons seeking to serve in the elected offices and on boards and committees of the Huntsville Presbytery
- 11. APPOINTED Select Committees.
- 12. RECEIVED excellent hospitality from the host church, St. James#2 CPCA. The Presbytery expressed words of thanks and gave a standing ovation to the Pastor, the Reverend William Robinson and the St. James#2 CPCA.
- 13. AFFIRMED the 2017 meeting of the Summer Huntsville Presbytery to convene in Huntsville, AL with the Union Hill CPCA to serve as host.

- 16. REFERRED BOARDS/COMMITTEES/AUXILARY REPORTS to the appropriate select committee.
- 17. ADOPTED THE BOARD OF BUDGET AND FINANCE REPORT CONCURRED with the recommended amount from the BOB&F of\$2500.00to the Mt. Sinai CPCA toward the building of their Fellowship Hall.
- 18. ADOPTED THE COMMITTEE ON MINISTRY REPORT

CONCURRED that the Huntsville Presbytery Stated Clerk remove the following names from the Huntsville Presbytery roll and request that the CPCA credentials (license and ordination documents) be returned to the Huntsville Presbytery: Reverend Eugene Anderson, Reverend Petra Bess, Reverend LaTonya Crutcher, Reverend Michael Crutcher, Reverend Marcus Gilbert, Reverend Darius Holden, Reverend Dr. Marcell Johnson, Reverend Betty Allen Jones and Reverend John Jude.

CONCURRED that the Huntsville Presbytery Stated Clerk removes the following names from the Huntsville Presbytery Roll: Reverend Lorene Powell deceased and Reverend Debra Matthews-requested and was granted her letter to move to the New Hopewell Presbytery.

CON CURRED with the replacement of HPCOM member Reverend Doctor Marcell Johnson with Reverend Dr. Edward Anderson.

CONCURRED that the HPCOM will provide a Status report to the Church Sessions that have Probationers and Licentiates.

CONCURRED with the recommendation to license the Brother Jeffery Toney in the 2016 Presbytery as all requirements for licensure have been met. CONCURRED with Pleasant Grove CPCA Pastoral Application, posting of the application on the HP and GA Websites, distributing copies of the application package at the Call Meeting of the AL Synod on April 23, 2016 and the closing date of31 May, 2016. CONCURRED that the HPCOM will continue to work with Pleasant Grove CPCA to determine Pleasant Grove's status with the Huntsville Presbytery. CONCURRED that the Pastoral Search Documents be added to the HP Constitution and Bylaws Appendices.

CONCURRED that the Reverend Dr. Debra Matthews request to return to the Huntsville Presbytery be approved.

19. ADOPTED THE BOARD OF JUDICIARY HP COMMISSION TO

CHURCH STREET REPORT

CONCURRED that Sessions be encouraged to have their deeds looked at for correctness and recognize/accept the need and process for church incorporation. This is necessary to properly protect all CPCA churches property. **CONCURRED** that the commission be allowed to do further work with the Church Street Congregation.

CONCURRED with the finding and action of the BOJ in regard to a letter from a member of Blackburn Chapel CPCA in regard to the concern over the pastor selection process within the congregation. **Finding:** Letter did not meet the requirements of an appeal. **Action:** It was determined that the identification of the imperfect process did not outweigh/overrule the outcome of the pastor selection.

20. ADOPTED THE REPORT OF THE HP COMMISSION TO PLEASANT GROVECPCA

CONCURRED that the HP Commission to Pleasant Grove retains its commission status through the pastoral search, and the installation of a pastor at Pleasant Grove CPCA.

CONCURRED that the HP Commission to Pleasant Grove retains its commission status until such time as the Commission determines that Pleasant Grove CPCA is in good operating order.

CONCURRED that the Huntsville Presbytery ascertain the will of the 19 Huntsville Presbytery Congregations concerning unification; and that the Huntsville Presbytery decision whether or not to merge be decided on the input from the 19 local congregations.

CONCURRED that the Huntsville Presbytery revisit decision of making annual contributions to the Malone-Weir Foundation; and if budget allows, that the Huntsville Presbytery resume its annual contribution of \$3000 effective immediately.

Engrossing Clerk's Report: CONCURRED

HPEB'S Report: CONCURRED

CONCURRED that the Huntsville Presbytery dissolve the Committee on Theology and Social Concerns based on the duplication of the General Assembly's prior establishment of these duties and are readily available on the General Assembly's website.

Curator's Report: CONCURRED HP Council: CONCURRED

CONCURRED with the Select Committee on Executive Review recommendation that the Huntsville Presbytery Council based on their Focus and Objectives provide a forum for Ministers, Elders, Deacons and Members of the Huntsville Presbytery to discuss matters and issues related to the Huntsville Presbytery and to provide recommendations to it within the 2016-2017 calendar year.

- 23. <u>ADOPTED THE AUDIT OF THE FINANCIAL RECORDS REPORT</u> DENIED the recommendation a \$300 honorarium for Reverend Versey Jones and \$150 honorarium for Reverends Cedric Pollard and Remisia Snodgrass.
- 24. <u>ADOPTED THE CHRISTIAN EDUCATION REPORT</u> CONCURRED that all HP Congregations support the 2016 HP Training by participating on Saturday, September 10,2016.
- 25. ADOPTED THE MISSION AND EVANGELISM, MISSIONARY SOCIETY, JR. MISSIONARY SOCIETY REPORT CONCURRED that the BOM&E continue review of Evangelism Strategy to reach communities CONCURRED that the Missionary Society establish working By-Laws
- 26. <u>ADOPTED THE HISTORICAL COMMITTEE REPORT</u> CONCURRED to replace non-participating members

CONCURRED with the Select Committee on History that the Historical Committee conduct more than one meeting per year

CONCURRED with the Select Committee on History that the Historical Committee make recommendations as to how the committee should proceed because if we are to fulfill committee responsibilities we must involve and coordinate with all churches

CONCURRED to establish and maintain a library for historical documents and noted that this is an important task due to our aging membership CONCURRED that the Historical Committee will work to implement the prior committee recommendations: a letter will be sent to each church informing them of the committee's objective/mission, suggest that each church begins to document (produce a written historical document), prepare a standard format, (for example: include prior Pastors, Elders, Membership, and special noteworthy activities). CONCURRED that it will be the responsibility of the Elder Representative to coordinate with the Committee Chairperson.

27. <u>ADOPTED THE HUNTSVILLE PRESBYTERY SUNDAY SCHOOL</u> <u>CONVENTION AND CPYF REPORT</u>

CONCURRED that the Body (Sunday School Convention) be reminded that all delegates who accept an office or membership on a standing committee are willing to serve, attend and participate in all scheduled or called meetings set forth by the Huntsville Presbytery Sunday School Convention Executive Committee.

28. <u>ADOPTED THE COMMITTEE ON STATISTICS REPORT</u> CONCURRED that congregation reports of the Huntsville Presbytery Churches should be completed line by line as requested.

29. <u>ADOPTED THE COMMITTEE ON CHURCH SESSION RECORD</u> BOOKS REPORT
